CALL TO ORDER/CERTIFYING A QUORUM – The meeting was called to order at 6:25 PM by President, Gene Rado. APPROVAL OF AGENDA – Mary Buckley **motioned**, seconded by Andrea Russell, to approve the agenda as written. **The motion passed unanimously**. Gene Rado requested that Judie Littell have the draft agenda ready seven days before the meeting with the final three days prior to the meeting.

1. Proposed Budget Review for 2020 – Bill Beall **presented** the **proposed** budget. It is based on 218 homes. FLP will receive a 3% raise which is good for two years and the contract will have the price per home in case new members sign up. PCM will receive a 3% increase. There is a \$5 increase from 2019 to \$140 per home. Gene Rado **motioned**, seconded by Mary Buckley, to approve the proposed 2020 budget and have PCM mail it out on October 21, 2019. **The motion passed unanimously.** Gene thanked Bill Beall for doing a very good job.

Dorothy Bryson – Garden Masters needs to do a better job on the weeds on the grass between 7608 and 7612 Teal Trace.

Ellen Linton – 6019 Wingspan Way – wanted advice. When she bought her house, it was quiet 6 to 8 months ago. She needs help on handling the noise from a pump that CDD installed between her house and the utility easement. She wanted to know if the association would put plants on her property to muffle the sound. Andrea Russell said the pump is very noisy. Gene Rado will go to her house and speak to the CDD on her behalf. **She was also advised to contact Manatee County Noise Abatement.**
