CALL TO ORDER/CERTIFYING A QUORUM – The meeting was called to order at 6:30 PM by President, Gene Rado. Other Board members attending were Bill Beall, Mary Buckley, Donna McGregor, Dan Powers, Andie Russell and Debbie Tyo. A quorum was established. Judie Littell, LCAM, represented Progressive Community Management, Inc. (PCM).

Donna McGregor followed up with the homeowner on three occasions and nothing has improved. GVLA cannot fine them but the ARC committee can. They will respond to the homeowner. The Association did their part by notifying ARC. Donna will find out when the 30 days are up. We get numerous request about the high water bills. Florida Lawn Pros checks

irrigation all the time. They say it is not irrigation. There are issues with Manatee County who incorrectly reads the meter. New meters are needed. If this continues to be an issue and the homeowner is not getting anywhere with Manatee County, it is suggested that the president talk to Vanessa Baugh or Darby Connor in the CDD.

COMMITTEE REPORTS

Web Site – Paul McGregor – we are looking for a web site master which is advertised on the front page of the web site. There have been 27,000 hits on the web site since it was formed. There is training provided by PCM. The web site is very user friendly. The person does not have to be very technical or a programmer. You can use your phone to take photos and work in a document system. He will ask Kristen Raniere if we can put the notice in the mailing tomorrow.
