President's Report – Gene Rado reported : As you all know PCM, along with other Management firms in Sarasota and Manatee, was hacked and held for Ransomware in mid-July. The FBI was called in and are still working on the case.

PCM has had their staff working overtime and hired a lot of temps to perform key in from paper. As you would imagine this is a very tedious process, prone to error and time consuming.

Over the past month I have worked very closely with PCM for about 50-60 hours to ensure our community's database of owners and our financials are in order.

We have been working together extensively throughout the process. Both have been extremely attentive, cooperative and helpful. I called and emailed Bill Sutton, Owner of PCM, to inform him as well.

I would also like to take a minute to review our purpose as a Board. Our goals are to create a lean, but achievable budget, diligently monitor expenses and stay within budget. We also are responsible for checking trees, bushes and grass to ensure a good job is being done to keep them healthy and

prosperous. We have already had two droughts this year. Both have caused some damage, but thankfully not excessively so.

Our main goal as a Board, however, is to ensure that our community makes a great appearance. It's time for mulch. If we apply too little mulch, weeds will appear, particularly in the summer months. The cost of FLP handpicking the weeds will exceed the cost of the mulch.
