34 8 Trees at Various Homes - \$2,450: Board discussion was had. Each owner would need

36 these trees upon approval by the owners, and not replace any of them. If a replacement tree is
37 requested by an owner we will evaluate that on an individual basis. Unan.

- 56 Larry McGoldrick: Brought up the topic of getting credits from TruScapes for the lawn cuts
57 that they missed due to the recent storms. **Motion** by Larry to ask for an additional credit for
58 the 2nd cut that they missed in October, or to make up the cut. There was no 2nd. The motion
59 dies.
 - 60 • Our total bill for Hurricane cleanup exceeded \$17,000 and we talked about it being
61 closer to \$13,000.
 - 62 • Kathy Zuege: It looks like TruScapes has slowed down a bit in the last couple of weeks on the
63 mowing, which is good, however they are still not doing a great job edging and weeding.
 - 64 • Jesse Rutherford: Would like to see a copy of the invoice for the mulch that they actually
65 purchased. It appears that we may have gotten less mulch than they were quoted. They picked
66 up several pallets of mulch after they completed the work.
